**INFORMATIONAL AND DISCUSSION ITEMS**

1. CI graduation language requirement – there is a bill that will require we recognize the seal of biliteracy. We should send some version of this to Senate. Sharing with GE first. There are lots of constraints, but many of them can be modified.
2. American institutions unit requirements – should this only be 3 or 4 units? This is concerning to many disciplines that are concerned with how many \*other\* courses in the discipline students will be exposed to. May or may not be in policy (the 6 unit requirement), but should replace it with a Senate policy.
  - a. We need to identify what parts of the catalog to modify and modify or codify.
  - b. We do not currently have a course that meets both parts of the legal requirement. Should we have one? It would have to be 4 units.
