Curriculum Committee Meeting 10/11/17

Co-chairs Jeanne Grier and Blake Gillespie met with Janet Rizzolli and Andrea Skinner to get a birds eye view of CC's projects this year

Overview

1) The GE executive order will occupy most of Janet and Blake's time over the next few weeks. Those projects will lead to CC work, but most of these will be trivial changes at the CC level, i.e., they will not require significant scrutiny from the faculty on the committee. Some GE projects will uncover problems that will be significant, i.e., they will require program modification. Janet and Blake B. will keep us apprised of major CC issues that arise from the GE review.

2) Discussions on the math executive order have not included any CC membership yet. I (BG) see this as a problem, and will ask Scott to convene a meeting with relevant parties.

3) Aside from the GE issues, there are 7 major projects: 2 Master's degree modifications, 1 new Master's degree, 2 undergraduate program modifications, 1 new program long form, and 1 package of projects from Liberal Studies. I've outlined these below, from high to low difficulty. <u>I proposed that Janet include a CC member assigned to a given project to join her in her preliminary discussions with program chairs/proposers. This will mean earlier participation of CC faculty members in the project evaluation process. We (i.e., all of us together) will start assigning faculty members to these projects in the coming weeks.</u>

4) Hidden pre-requisites discovered while addressing the abovementioned executive orders may result in additional work for CC. We won't know the topography of that landscape until the GE committee is done, but we agreed that it makes sense to try to address the program changes required by the discovery of hidden pre-reqs during the current cycle.

5) Curriculog allows proposers to create new (unapproved) prefixes. These specific prefixes, and the issue of new prefix generation needs to be addressed, probably in conjunction with someone like Hung Dang.

Biotech	straightforward modifications proposed derive from student feedback and accreditation concerns
