1. Emphasize interdisciplinarity by integrating content, ideas, and approaches from two or more disciplines

The course is cross-listed with Chicana/o Studies and incorporates the approaches of both disciplines in both content and approach. In addition, the readings include articles from sociology, history, and economics. The study of immigration requires a holistic, interdisciplinary approach. In addition, the research questions coming out of the study of migration often require a mixture of research methods and approaches.
2. Include substantive written work consisting of in-class writing as well as outside class writing of revised prose.

Examples of appropriate written work include: short papers, long papers, term papers, lab reports, documentation, disciplinary-based letters and memos, and essays.

The students will have in-class writing, reflection pieces, two short analytical papers and a long research paper.

1. Promote understanding of how the issues relevant to social, political, contemporary/historical, economic, educational or psychological realities interact with each other within the realm of human experience

The issue of immigration is an ideal topic to address from multiple disciplines. The readings assigned will include articles from sociology, political science, history, and economics. In addition, we discuss education policy and psychological triggers in reaction to immigrants and immigration policy. The combination fosters understanding of how the interaction of these various realities impacts the politics and policies surrounding immigration.
2. Focus on how a social science discipline conceives and studies human existence

The various forms of social science research (as described above) provides different frameworks and methods so the students will be exposed to different ways in which the social sciences conceive of and study immigration.
3. Address issues using the methods commonly employed by a social science discipline

The students will read articles using different social science research methods. In addition, they will be required to write a research paper and present their findings using appropriate methods.
