Proposed Name of Minor: Environmental Science and Resource Management
Faculty Proposing Minor: Mark Zacharias, Ph.D

1. Catalog Description:

Minor in ESRM (23 units)

The Environmental Science and Resource Management minor provides non-majors with the opportunity to explore environmental issues and examine human impacts on natural systems. The Environmental Science and Resource Management minor provides students with an understanding of how their personal choices affect the environment around them. In addition it equips students for further study in environmental science, law, policy, or management.

2. Justification for Proposed Minor (< 100 words):

Environmental science and resource management as a discipline is offered at most colleges and universities in the US and abroad. It is of particular interest to students interested in natural resource management, environmental science, government, public policy, and environmental and human health issues.
