3. Justification and Requirements for the Course. (Make a brief statement to justify the need for the course) A. Justification: This upper division art history course is a much-needed addition to the Art Program curriculum for art history option majors. This course is an elective upper division requirement for art history option majors. A similar studio course is presently offered for all other art majors. Students have expressed their interest in taking more specialized art history upper division courses that would give them the opportunity to explore the identity of the field and focus on certain topics and themes. The Art Program plans to offer the course every 3 semesters.

The purpose of the course is two-fold. 1. To introduce students to the development of art history as a discipline and to expose the role and history of its fundamental institutions: academies, museums, and galleries. 2. To give students the opportunity to focus on particular topics/ issues/ work of arts. The topics analyzed and discussed in the course will deal with specific themes and subject matters from cross-cultural and chronological artistic environments. When possible, the topics selected will be linked to local exhibitions and museums /collections to allow students to examine the original works of art discussed. Furthermore, participation in art historical symposia, lectures, and conferences pertinent to the topic will be integrated in the course activities.
