Dan Wakelee explained that he was charged with reviewing the current AMP, in the current AMP (Academic Master Plan) there 15 programs: 6 already said they are not moving forward, 6 are moving forward 2 undecided and 1 approved Global studies BS. And he was also charged in developing a new process to manage the AMP, how courses get added to it.
