## INFORMATIONAL AND DISCUSSION ITEMS

- Info on mechatronics major
  - Janet & Blake & Barbara have gone over the long form.
  - There are 16 units of hidden prerequisites.
  - Total major is at 143-144 units (that's more than 120, btw).
  - Janet has given it back to Ivona and Michael with edits.
  - The roadmap does not quite match the course list.
- Health science (informatics option) is not going to start as planned. It ought not appear in the CARR, etc, in Fall 2016.
- Discussion w/ Bob Bleicher re: Liberal Studies Online
  - Bob reviews the details of the program highlights document (saved in folder)
  - In the "first" courses of the online program, Bob asks instructors in introduce the pillars (currently that doesn't happen in a class, but in orientation, etc).
  - Q: we have the justification for this program. This is a very specific list of courses. How are these course mapped to the themes? E.g., some of the "multicultural" courses are not "GE multicultural"?
    - Bob—I think those are, but we can check. But LS went through the course catalog to find classes that fulfill each of these pillars, then whether the course would do well in an 8-week online format.
  - Bob: to map courses to pillars, and to structure the major, used rubrics from the pillar centers. Also relied on department chairs to help guide these choices.
  - Between this draft and this, it seems that there are now objectives (pillars) and a path to those objectives (starting and ending assignments in particular course choices).
  - Q: how do we assure course quality for our online courses?
    - Bob: we have a lot of support on the front end, had to document how this happens in WASC. Have on-campus support for structuring online classes.
    - This—ensuring the quality of \*classes\*--is an issue we should revisit in general (not with LS, or not just with).
  - This is the most that students would take at CI; they may take less. They may also get credit for "life experience."
