Title Public Archaeology

Description: Focuses on the practice of archaeology, as well as public perceptions and uses of archaeology. Considers the challenges of dealing with the many public concerns with the archaeological record, including museum interpretation, indigenous perspectives, public archaeology programs, ecotourism, looting, and vandalism. Field trips may be undertaken.
