We plan to offer this face-to-face for our stateside program; it will be offered 100% online for the proposed B.A. Liberal Studies (Degree Completion Program in Partnership with Calstate online). In the online platform, students will be required to contact a community partner in their area and provide a miniumum of 25 hours of service based on the partner organization's needs. A supervisor in the community organization will verify the hours served and complete an evaluation of the student's performance. Students will complete written reflections on a weekly basis as well as a final reflection. They will also be expected to participate in an asynchronous interactive course discussion board sharing their own experiences and reflections and responding to a minimum number of posts from their peers.

I'm sorry it has taken us so long to get back to you on this. Quite frankly, we're still just learning about our role in the curriculum process. As I mentioned, I took the opportunity to meet with Alison Perchuk last week to find out more. In the future, we're going to try to create a more systematic process for review and approval of service-learning courses – so thanks for the opportunity to get us pointed and moving in that direction!

In the meantime, I think all you need is our informal approval – and we're happy to provide that. We know that you have a lot of experience in the field of service learning – as you know, we both really liked your article (with Manuel) on SL reflection. I found the course proposal that you sent a little difficult to follow – but I assume that is because you were trying to use the general course proposal format to present service-learning structures and outcomes (so, a bit of the square peg and round hole, as it were). But, again, we believe you have a solid sense of what is necessary for a good service-learning course. At some point down the line, we would be interested in sitting down and discussing the course more fully – but that isn't necessary to move it along at this point.

So, you can let the Curriculum Committee know that we're on board with the course – and then we can talk more at some point later this year. Sound good?
