Senate Materials for April 29th

We have six second reading items on our agenda ready for a vote at our final meeting on April 29th. Faculty Affairs Committee submits two policies for consideration. The first is SP 13-11 "Student Opinion of Teaching Survey" that would supercede SR 08-01 and SP07-19 and replace the current Student Ratings of Teaching (SRT). The Committee has made revisions to the document presented at first reading and also prepared a comparison of the current SRT and the proposed changes in the new instrument. The second policy from FAC is SP 13-12 "Policy on Mode of Instruction" that aims to clarify the process for changing the mode of instruction of individual courses.

The three other policies we see are from Research and Sponsored Programs and are needed for compliance at various levels. These are new policies that have been approved by the President's Policy and Planning Council, and are now before senate as second reading items. These policies are "testing" our new routing system for policies that have both faculty "academic" and university "administrative" implications. Changes made in either body will need to be reconciled with the other so we result in a single policy. These policies are: 13-13 Policy on Pl Financial Conflict of Interest, 13-14 Policy on RSP Records Retention , and 13-15 Policy on Subrecipient Monitoring.

The final item for second reading is SP 13-16 2017-2018 Academic Calendar. Several suggestions were made at our last meeting about revisions and I will report on what I heard as responses about these items.
