- 2) Approval of the Minutes from 26 October 2021*
 - a) Kklompier: I asked the Provost if lectures could attend Charting Our Course, and he answered yes, and I would like this to be added to the minutes.
 - b) Approval of amended minutes with no objections 2:39 p.m.
- 3) Report from CFA
 - a) DBaker read petition signed by 146 faculty to support Faculty demands in current collective bargaining.
 - b) Updates: monitoring on AB928, submitted intent to raise question on campus policing
- 4) 2nd Reading Items
 - a) Policy on Academic Notice/Disqualification (SAPP) *
 - b) MSoenke: Changed language to “Notice”
 - c) MS: Made sure the language is consistent throughout the policy
 - d) MS: Addressed how to handle issue of students admitted conditionally
 - e) **Policy passes: Y: 51; N:1; Abstain: 9**
- 5) 1st Reading Items
 - a) [ASI Resolution 007](#) (SENATE OF CSUCI STUDENT GOVERNMENT)
 - i) **Motion to discuss: CHarris**
 - ii) **2nd: VAdams**
 - iii) VRamprasad presented student resolution to continue C/NC option due to continuing socioeconomic, health, and caretaking challenges caused by the pandemic.
 - iv) MAVila: A difficult conversation. We are committed to student success. The question is what is the compassionate response that is in the best interest of our students. No other CSU is considering extending the option for Fall 2021. For better or worse we have come to a place where we could predict what the semester will look like. There are challenges around childcare. C/NC does not necessarily lead to better student outcomes. I recommend not approving this.
 - v) CForest: There is an 18-unit limit for how many withdrawals students could take. That is currently intact. If no documentation is required to withdraw, some withdrawals could be more punitive for students. Could hinder student progress.
 - vi) BVeldman: This is a transition semester. We are dealing with trauma. I am concerned that we are privileging students who might game the system rather than the students in crisis now.

- vii) MRivas: We have daily drop-in advising available. There a lot of students who are coming in and trying to do late withdrawals. Some students did not know the policy changed.
- viii) GBuhl: I don't like all of the policy. C/NC is useful. I support the plan because students are in crisis.
- ix) GWood: Department by Department you could deem certain courses as having to be taken with a letter grade.
- x) VR: We do acknowledge that there are ramifications and that certain courses are necessary for graduate programs. We need more professors that talk about this and more marketing about ramifications. There are a lot of benefits to C/NC. Many students are inquiring about the option.
- xi) JGrier: We need the list of classes that must be taken for a grade available to students and Chairs.
- xii) **GB: Motion to amend SR-20-08 with the language in red: “BE IT RESOLVED, that the Academic Senate at CSUCI agrees to extend the provisions of SR 20-08 excepting the clause, BE IT ALSO RESOLVED that students may withdraw from any Fall 2020 course as late as December 18, 2020, and no faculty or Chair signature will be required for withdrawing from a Fall 2020 course. The Registrar shall not require additional outside documentation to support a student’s reason for withdrawal (such as doctor notes, employer notes, ect.) and may accept electronic requests of withdrawal. Analogous dates will be established and advertised for Spring 2021, and”.**

The policy does not change anything; it simply articulates the process by which we identify a service-learning course on campus, registration, management system that archives agreements with community partners and allows students to register.
- ii) PPacheco: This policy operationalizes the way that we designate Service-Learning courses on our campus and aligns better with Service-Learning best practices that our faculty follow.
