Reports from Vice Presidents

Report from Academic Affairs, Steve LeFevre, Associate Vice President for Academic Affairs. Steve reports that the budget presentation for the university went well. Academic Affairs includes the library, instruction and admissions, and its proposed budget will be \$13.4 million. The entire university budget is over by \$6 million. A special committee has been formed to identify areas that can be reduced to meet the budget. The governor of California may attend the opening day ceremonies; the time of the ceremony may be moved earlier to accommodate his schedule. A committee is working on the mission statement and is close to producing a more concise university mission statement. Additional faculty office space is being investigated in other areas of the university. Some space near the Library and the Art complex is being investigated for next year. A proposal for the furniture layout for the faculty conference room is being considered to accommodate the entire faculty.

Dennis Muraoka reports that he is working closely with Louise Lutze-Mann preparing for the opening day.

Report from the Special Committee on Elections

The committee reports that the new Academic Senate Vice President is Jacque Kilpatrick. The new Academic Senate Secretary is Phil Hampton. Phil relinquishes the office due to his new responsibilities as Academic Coordinator of Liberal Studies. The committee will run another election for the secretary position.

Report from the Vice President for Student Affairs, Greg Sawyer

There is one month and one day until the student orientation. Greg will begin meeting with Louise Lutze-Mann for advising. Orientation will include getting acquainted with the institution, registering for classes, and retention based activities. There is an opportunity for the faculty to participate in a "Last Lecture" series. A welcome celebration will be held on August 25th. It will include a painting ceremony, Hands in Support of New York City. The CHAPs program is currently being set-up and includes Career, Housing, Accommodations and Personal Counseling. In Student Development, Tony Rice will handle student discipline. The recreation office will be looking into setting up a fitness center, activities, clubs, and organizations. As soon as students arrive, they will organize the Associated Students and approve a constitution. Regarding Financial Aid, Channel Islands and Northridge Financial Aid will be run from the same office here, but CI students will have their letters packaged from here, while Northridge student's letters will be packaged at Northridge. The Outreach and Development Office is calling to invite every student to the orientation. The Outreach Department and the Admissions Department will now work together. The Records Department now becomes part of Academic Affairs.

Clarification from the Senate Chair, Dennis Muraoka

Regarding our membership to the statewide Academic Senate, we will get one representative to the Senate next Spring. There is an amendment pending that may provide us with two representatives. An election will be held for the observer to the statewide Academic Senate after the election of the Academic Senate secretary.
