    - ii. Discussion:
      - Sean Anderson how does this affect existing programs? How do we evaluate these new programs? Do we have a response from Provost's office? Waiting 3 years for some evaluation model.
        - Response (Michelle Hasendonckx) I am here representing the Interim Provost, and I am taking notes.
      - 2. Jim Meriwether We don't want it attached to any particular program. What is the plan to onboard new programs while maintaining the health of our existing programs?
      - 3. Nancy Deans It is worth it to understand implications of staffing on this
      - 4. Richard Yao We've been waiting for 2.5 years for new programs to have a way to get evaluated (in so many ways). I met with Interim Provost, I got a glimpse of some of what these comments are asking for. Cost model used to be done in isolation, Jackie has done a great job integrating cost model

into the school itself. Interim Provost is getting ready to roll this out.

- Tabitha Swan-Wood With new Programs, I'm asking to hear from Staff Council. How does this shift their burdens in loads? Outside of budget, just workload.
- Monica Rivas There are some considerations to be made, especially when proposing undergraduate programs. Usually, more programs does not mean adding more staff. It adds to advisor's load.
- b. M.S. Business Analytics Degree Program (Time: 5 minutes) Minder Chen presented information

  - ii. No comments or questions.
- c. GE Policy on Program Course Requirements (see attached) presented by Reha Kadakal
  - i. Brown Bag Information: Dates TBD
  - ii. Reha Kadakal There will be one or two Brown Bags, still working on dates. These policies are not the end of the work of GE. Hopefully this will be starting point. Over summer, GE Task Force went through existing courses and policies and updated as necessary.
  - iii. Discussion -
    - Sean Anderson Section 1 #3. Issue with courses must be offered at least once per year. This could be an issue with enrollment. What if we add something to the nature of "intended to offer"?
    - 2. Colleen Forest request to translate the GE with units in policies
    - Jose Alamillo what is the rationale behind Section 1 #4. Why can't courses be crosslisted? This promotes being interdisciplinary.
      - Response (Reha) crosslisting and interdisciplinary do not follow each other, they should be. It is difficult to assess GE courses. There is more of a desire to decrosslist. Programs lose control over course. Courses still can be interdisciplinary. Courses can still be crosslisted – just not GE.
      - b. Sean Anderson this would cause us to drop a class.
  - iv. Jim Meriwether it would be nice to know what in these policies are prescribed and what is under our own control. We need a broader conversation with some of these things. What is the timeline? There needs to be broader campus discussion.

- 1. Response (Reha) we are working on brown bags. Framework and unit requirements are by CSU. We need these policies so that we can have these conversations.
- v. Cindy Wyels I'm asking to be clear in the materials...what is mandated by Chancellor's office and what is open by campus choice?
  EO 1100 – in section 1 #1 the date is an issue.
  - 1. Response (Reha): EO 1100 has been revised/updated but name stays the same.
- vi. Colleen Delaney Thanks to GE Task Force. Policy 2, #7...Issue with Programs only being able to offer 3 upper division courses, especially for smaller programs.
  - 1. Response (Reha) GE committee is aware of situation that smaller programs are in. We don't want GE committee to be in position to determine how many GE courses a program can have. There is nothing a program can do with 15 GE programs that they cannot do the same with 10. We recommend having multiple sections of GE, rather than multiple GEs. This is a campus issue not a GE issue.
- vii. Alison Perchuk this work is important. For the Art program, there are similar issues as Anthropology. I recommend a clean version of Document 1 to have the minimum requirements from EO 1100 to give more time for faculty to discuss.
- viii. Motion to table this Policy to have more conversation (Alison Perchuk)
  - 1. Second from Cindy Sherman
  - 2. Discussion
    - a. Christina Smith this doesn't have to come back as a 2<sup>nd</sup> reading, there are lots of options to keep in mind with discussion.
    - b. Nancy Deans What will this tabling for?
      - i. Alison Perchuk rephrases motion.
    - c. Reha Kadakal needs further clarification on this motion. There are not resources from GE committee to re-draft this policy. There is nothing here that convolutes the existing CSU policy. We need policies to review and access GE courses. We cannot do our job without proper GE policies. There is nothing here that is not basic CSU campus framework.
    - d. Sean Anderson this is another effort to tame GE. It seems to always fail. While I would normally like more time, I think this is an opportunity to have taming and standardization of GE. It would be unfortunate to have bare minimum. I don't think there would be a huge

amount of difference after editing. I will vote against the motion.

- e. Jim Meriwether I'm in support of motion. I find it concerning that whole task force is not here. I do believe that a lot in the policy is not mandated. We need to have a conversation about it.
- f. Ryan Murphy (member of GE task force) there were 7/8 faculty members, all from different programs. These 3 policies represent a best faith effort to leave no stone unturned. It speaks to EO 1100 and our campus at CI. These are recommended policies, open to further revision. In GE committee, our work would be stalled without policies of this nature.
- g. Alison Perchuk the policy does contain items that are not part of EO. Policies may have parts necessary for many reasons, but as not included in EO. There is pressure from WASC for assessment. The pressure should not be felt just by GE, but the entire campus.
- h. Jared Barton you could add an addendum during second reading. Econ will be voting against this motion.
- i. Cindy Wyels this is complicated work, and yet I might not have time to re-think this work over the next 2 weeks. A lot of work went into this. We are asking for the people who have done the work to explain more so that we as representatives can explain to our faculty, so they know how to vote.
- j. Greg Wood there would be time to have discussions during brown bags. What if we informally agree to push the second reading back at least one senate meeting, hold the brown bags, and provide a version that shows what is required/not required. And say we are open to 2<sup>nd</sup> reading in the future, but not in 2 weeks but rather a month. Does that work for all parties?
- Reha our understanding is to start the conversation today, hold the brown bags, and then have the 2<sup>nd</sup> reading when ready.
- I. Christina Smith I'm hearing concern that 2 weeks would be too soon for a 2<sup>nd</sup> reading.
- m. Cindy Sherman if we table this now, what does that mean?

- i. Response (Christina Smith) it starts the process over again. It would come back to senate as a first reading.
- 3. Vote: 16 yes, 22 no, 7 abstain

- ix. Greg Wood I want to make a motion wait at least one extra senate meeting for 2<sup>nd</sup> reading. We ask Committee to bring details with what is required by EO vs. optional from policies.

  - 2. Greg Wood withdraws motion.
  - 3. Alison Perchuk tries to second motion, does not go through because motion was withdrawn.
