- a. M.A. Early Childhood Degree Program Proposal Mari Riojas-Cortez presented
 - i. Motion to approve Chuck Weis
 - ii. Second Greg wood
 - iii. Objection unanimous consent not reached.
 - iv. Discussion
 - 1. Alison What is the impact on undergraduate teaching?
 - a. Mari we are counting on lecturers that are qualified to teach, also will have 7 tenure line faculty. Work doable. Programs will give us more students and lecturers will have more opportunities to teach here.
 - 2. Sean Anderson I need guidance from leadership to be able to evaluate programs, no framework. Classes now can't have less than 20 students, what is the impact.
 - 3. Annie White having this program online is strategic we are able to serve the region and statewide. There is a need for MA to elevate teachers/early childhood prof. into next level. With the doctoral program in summer 92 applied right out the gate. Having this program will elevate and increase due to it being online vs. in person.
 - 4. Lina Neto these programs were checked by admin and APPC, and take into account implementation, however budget also changed too. There are criteria that have been drafted, APPC is working on rubrics. There is a decision to not impact programs into process. Programs have been vetted to have good enrollment. Idea to not impact what is submitted for fall 2025. We will look at things in AMP in fall 2026 and beyond.
 - 5. Matt Zivot Interim provost sent out rubrics with report that was emailed to all senators prior to meeting.
 - Greg Wood SBC is passing on summarized information (not an endorsement). This can be covered through tuition alone, not taking from one place and funding another – that is the intent.

- 7. Jim Meriwether Can we clarify, are these proposed programs ones that are prioritized in some way or simply got paperwork done fastest.
 - a. Response (Lina) response: APPC not first come first serve. Proposals split through time to not be overloaded on campus. Authors involved as to when the program is coming ex. MS in biology where faculty decided to take more time. Everything that was already in AMP to be implemented fall 25 is still going on. APPC is looking at items coming fall 26 and after.
- 8. Chuck Weis criteria established by prior provost w/president. Criteria stayed the same, rubric is flushed out for programs moving forward.
- 9. Cindy Wyels we are missing a strategic plan of what we can afford.
- 10. Marianne McGrath we have a program that is stalled without funding. Lack of communication/commitment is hurting the program with no response.
- 11. Annie we have pro forma developed early on to look at and do projections and questions are raised on the senate floor.We had the brown bags, there were only 2 questions.Positions are filled and the program is ready to go.
- 12. Nancy Deans we are asked to vote without being able to raise questions. We are discussing individual things without discussing how to address big picture.
- 13. Alison how can a program have 0 academic affairs overhead? Maybe hiding someplace else in budget?
- 14. Mari as chair of ECS, part of the creation of this degree was from me. Having qualified early ed. teachers is important why we developed this program.
- 15. Tabitha there is a greater issue for senate exec to address. Idea to have a virtual discussion board where people put what they need to know.

- M.S. Business Analytics Degree Program Proposal (materials on Canvas) -Minder Chen presented
 - i. Discussion.
 - 1. Alison What is impact on undergrad teaching? No tenure track hires needed?

- a. Response (Cindy Sherman) We are working towards accreditation; we have faculty now in several diff programs with background in this area. Will continue to hire lecturers to teach undergrad courses.
- 2. Alison how does this fit into long term vision for MVS?
 - a. Response (Sue Andrzejewski) The Academic Senate and President Emeritus Rush approved the <u>MBA</u> <u>program in 2004</u>, and the MBA officially launched in 2005. We are thinking about our commitment to the region and expanding our graduate programs.
- ii. No objections, approved with unanimous consent.

6. New Business

- a. M.H.A. in Healthcare Administration Proposal (Link to materials HERE) presented by Sonsoles De La Calle: Self-study found that students were interested 30% in nursing, 30% in healthcare, and 30% in other aspects of healthcare. From community input, this is a need. We made a decision to include growth based on 3 grad programs MHA, MSW, MPA. The program includes the MHA itself but the important part grad certificate in gerontology a need in community. We had a \$50K grant from PACE. Our target is working professionals in healthcare. EU made a commitment to cover loss so the program can support itself. Less expensive per unit than other schools.

- b. Discussion:
 - i. Chuck Weis why self-support? How if it's losing money?
 - 1. Sonsoles using this model would allow us to really pay for it. We can put away investment, would give us all that we need to start the program.
 - 2. Chuck The pro forma doesn't show contribution from PACE grant. Why?
 - a. Sonsoles I will get back to you
 - b. Jaime Hannans grant is in health science online, not this program. That was incorrect. There is a commitment from EU to put program funds up front.
 Differences in cost will come from faculty pay increases over the years.
 - 3. Chuck Will there be tuition increases with faculty costs increase?
 - a. Jaime that takes planning. Goal for EU is to break even. We want to keep tuition affordable.
 - 4. Nancy I appreciate lecturers as a part of faculty. Not being stateside, lecturers don't get entitlement or benefits. They would need a full load plus load in EU. That is my concern moving the program forward.

- a. Sonsoles we do not have that concern right now. We still have 700 undergrads to teach. Our lecturers will be working in their profession. The way the program is growing, no expectation of changing stateside employment.
- 5. Alison These then would be working professionals who teach a side class OR tenure track faculty which means moving tenure track faculty to EU. How will you make sure students still have good access to tenure/tenure track faculty?
 - a. Sonsoles there are 14 of us who want to devote our time. Since its self-support, we can hire other people to contribute their expertise to this program.

 - ii. Greg: will send report; over 5 hr meeting of the fiscal policies committee. System asking for \$600M increase; but an 8% reduction, \$400M. \$160M in mandatory cost increases; will be detailed in budget request when it goes forward. CI is 1% of the system budget, so we'd be about \$4M down, of mandatory increases, for us maybe \$1.6M. Enrollment is rebounding but under target; last year it was down 4.9% for CA resident FTEs; this year 2.7% underfunded target.

System will improve; individual campuses vary. Planning to save costs by centralizing some administrative structures across sectors of system/system as a whole. Offer 2-yr marker/ceremony (not associates degree) as a way to encourage persistence; Prop 98 money; but don't want to undermine CCs.
